The most recent decade has accelerated this search, and has witnessed the creation of PESCO, an action to improve military mobility within the EU, as well as discussions on the European Defence Fund becoming part the next multiannual financial framework. The EU is building Strategic Autonomy in the defence field, while differences in opinion within the EU and between the EU and its traditional defence partners remain. Is unity on European Strategic Autonomy achievable? Will NATO countries that are outside the EU be effectively included?*
